## DRAFT BY-LAW NUMBER RA-189-01-2022 AMENDING BY-LAW NUMBER RA-189-06-2018 ON COMPENSATION OF THE ELECTED MEMBERS

## TO ALL WHO ARE INTERESTED

During the regular session of the Municipal Council held on December 14, 2021, notice of motion was given and a project of by-law was presented with regard to the municipal elected representatives' remuneration, in accordance with the Law on the remuneration of elected municipal officers.

The draft by-law aims to amend by-law number RA-189-06-2018 adopted on January 9, 2018.

By-law RA-189-01-2022, as proposed, shall enter into force on January 1<sup>st</sup>, 2022.

By-law number RA-189-01-2022, as proposed, establishes on an annual basis the base remuneration and the expense allowance payable to the mayor and his deputy, if applicable. In addition, members of council will be paid a sum of \$50.00 for their attendance at any meeting of a committee, of another organ of the municipality, of an organization mandated by the latter or of 'a supramunicipal body in which it sits.

By-law number RA-189-01-2022, as proposed, provides that the municipality of Grenville-sur-la-Rouge adheres to the pension plan established by the Act respecting the pension plan of elected municipal officers (RSQ, c. R -9.3).

Finally, by-law number RA-189-01-2022, as proposed, modifies the maximum rates applicable for different types of eligible expenses as well as the terms of reimbursement thereof.

This project by-law will be submitted for adoption during the regular session of the Municipal Council, which will be held on January 11, 2022, at 7:00 pm in the city hall, located at 88 rue des Érables, Grenville-sur-la-Rouge.
